## **Requirements for Marriage Certificate**

1. Original passport of the applicant.
2. If original Marriage Certificate issued by the Registrar of Marriages, duly attested by Home Department of the respective State Government and thereafter by Ministry of External Affairs, New Delhi or any of its Branch Secretariats in India, we may accept provided both the names are endorsed in each passport.
3. If original Kazi or Church issued Marriage Certificates are attested by Home Department of the respective State Government and thereafter by Ministry of External Affairs, New Delhi or any of its Branch Secretariats in India, we may accept provided both the names are endorsed in each passport.
4. Marriage Certificate issued in other country needs to be attested by the Indian High Commission/Embassy/ Consulate in that country.
5. Copy of Passport of applicant and spouse.
6. Copy of Marriage Certificate.
7. Copy of Civil ID of the applicant.
