Requirement for Driving License

Driving License for light vehicle

- Original valid Indian Driving License must be submitted.
- Details of Indian Driving License may be verified on **ParivahanSeva** portal (https://parivahan.gov.in/rcdlstatus/?pur_cd=101) using the Indian Driving License number and Date of Birth of the license holder.
- Self attested Passport and valid Civil ID copy/ entry visa copy of the applicant.
- Copy of Indian Driving License.
- Sponsor Civil ID copy in case of applicants under Visa Article 20.

Driving License for heavy vehicle

- Original valid Indian Driving License must be submitted.
- Details of Indian Driving License may be verified on **ParivahanSeva** portal (https://parivahan.gov.in/rcdlstatus/?pur_cd=101) using the Indian Driving License number and Date of Birth of the license holder.
- Self attested Passport and valid Civil ID copy/ entry visa copy of the applicant.
- Copy of Indian Driving License.
- For getting Heavy Driving License, the Indian Driving License should have valid heavy driving status.
- Employment Contract letter from the company which is duly attested by Kuwait Chamber of Commerce & Industry and Kuwait Ministry of Foreign Affairs.
- Copy of Company's Registration License (Etamatokiya).

Please Note:

- Applicant has to come in person.
- The Applicant must produce original Indian Driving License if not available may need to submit a request letter for prior approval along with online print-out.
- Additional documents may be needed for verification depending upon the documents submitted.
